**EXPRESSION OF INTEREST FOR PROVIDING MOBILE CLINIC  
SERVICES TO ESI BENEFICIARIES**

**1. Introduction**

ESIC a statutory organization under Ministry of Labour & Employment, providing comprehensive health care through a network of dispensaries and hospitals to its insured persons & their family, in majority of States/Districts of Country.

In its Reform Agenda under ESIC 2.0, the ESIC has decided to expand its services in all the districts and small towns of Assam and other North Eastern States like, Meghalaya, Nagaland, Tripura, Mizoram, Manipur and Arunachal Pradesh. In this endeavor, ESIC is extending its coverage to unorganized sector also and in these new implemented area it intends to provide primary health services through Mobile Clinics at certain selected IPs cluster locations.

**2. Scope of Services & Modalities of operation :**

- 2.1 The Mobile Clinic shall be made operational with a vehicle with one MBBS doctor and one staff on the board. Each Mobile Clinic will be stationed for 3 hours at one location, covering two locations in a day and visiting one location twice a week, thereby, covering a total of 6 locations per week.
  - 2.2 The Mobile Clinic shall be responsible for providing OPD services and some basic lab investigations like HB, TLC, DLC, blood sugar, urine test, etc.
  - 2.3 A separate procedure would be put in place for the provision of medicines to these IPs.
  - 2.4 The Regional Director / SSMC Office of ESIC will identify the locations to be covered by Mobile Clinic, once the area is notified for implementation.
  - 2.5 The service provider may apply for one or more than one locations.
  - 2.6 The selected service provider would sign a contract with the SMC of the State.
3. Expression of Interest is invited from primary health care provider clinics, nursing homes, NGOs, medical professionals, entrepreneurs for empanelment as service provider for primary health care facility. Agency will be selected for the state based on RFP to be circulated later on be selected. Financial aspect of the arrangement would be made known at the time of issue of result framework.
